Late bids will be rejected. Bids will be opened electronically immediately after the bid submissions in the presence of the bidders' representatives who choose to attend in person at **BarhabiseMunicipalityBarhabiseSindhupalchok, Nepal** at **14:00 hrs** on the same day.
- Bidders are requested to study bidding documents thoroughly before bid submission. The Bidder must submit all mandatory Documents (letter of bid; firm registration certificate; VAT registration certificate; Tax clearance certificate; BOQ with rate, amount and total amount; Bank voucher or tele-transfer receipt(if bid document down loaded), Joint Venture agreement (if firm is JV), Power of attorney of bid signatory (If firm is JV or Private Limited, Joint Company, etc.) along with the bid. Non -submission of above mandatory documents with bid, and bid shall be considered as non-responsive bid.
- Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting as in table below, which shall be valid for 30 days beyond the validity period of the bid.

In case of correction in rates, it should be signed by initials. Bids which are late, incomplete and contrasting to the notice will not be entertained. In case the rates quoted in figure and words differ, then the rates in words shall govern.
- The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
- Matters not covered by this notice shall be in accordance with bidding document, Public Procurements Act - 2063 and Public Procurement Rules -2064 and other Prevailing Regulations.
